CITY COUNCIL MEETING Monday, June 18, 2018 - 7:00 P.M.

1. Call To Order and Roll Call.

Mayor Flores called the City Council Meeting of Monday, June 18, 2018 to order at 7:00 p.m. City Clerk Joanna Cunningham called the roll.

Mayor Joel Flores led the Pledge of Allegiance.

A. <u>Presentation:</u> Gifts and Certificates of Appreciation to Code Enforcement Board Members. – Joel Flores, Mayor.

Mayor Flores presented former Code Enforcement Board members Benjamin Wade and Bert Molow with Certificates of Appreciation, and gifts for Merle Fine and Frank Simon for their 17 and 22 years of service respectively. Photos were taken of the recipients, the Mayor, and Council.

B. <u>Presentation:</u> Plaque of Appreciation from LC Swain to Mayor Joel Flores - Deputy Mayor Paula Bousquet.

Deputy Mayor Bousquet presented Mayor Flores with a plaque of appreciation for his continued perseverance in obtaining a school safety zone for L.C. Swain Middle School, to be installed on Lake Worth Road for the 2018-2019 school year. The Mayor was approached by a 12-year old student concerned with speeding and school safety. The Mayor then met with City and School District staff, County Commissioner Paulette Burdick and the Transportation Planning Agency.

C. <u>Presentation:</u> FEMA Plaque to City of Greenacres. – Joel Flores, Mayor.

Mayor Flores presented Director Michael Grimm with a plaque from FEMA recognizing the Building Department for the implementation of a City-wide Floodplain Management Program and being a participant in the National Flood Insurance Program (NFIP) ,which allowed the City to receive a Class 9 rating and a 5% discount to all residents on their flood insurance premiums.

7. Regular Agenda:

A. PUBLIC HEARING Ordinance No. 2018-03 – ZTA 18-01: (tabled from the May 21, 2018 Meeting) Second Reading; Amending Chapter 16, Article IV, Supplemental District Regulations, Division 6, Temporary Uses, Sections 16-718 and 16-719; Article VI, Sign Regulations, Division 1, Generally, Section 16-932, Definitions, and Division 4, Sign Standards, Section 16-991; to provide reasonable time, place, and manner regulations related to "Human Signs"; providing that each and every other section and subsection of Chapter 16. Zoning Regulations shall remain in full force and effect as previously adopted; providing for repeal of conflicting ordinances; providing for severability; providing for inclusion in code; and providing for an effective date; pursuant to Staff Memo and Staff Report. Kara Ferris, Planning & Engineering Director.

City Clerk Joanna Cunningham read Ordinance 2018-03 into the record on second reading.

Planning & Engineering Director Kara L. Ferris stated that as of the first reading of this Ordinance, some definitions were modified to clarify setbacks for human signs. With the exception of the definitions, no other changes were made; therefore, staff recommends approval of Ordinance 2018-03.

Mayor Flores called on Council members for comments. He asked for clarification on the number of times a year human signs would be approved.

Director Ferris explained that human signs would be allowed a maximum of 3 times per year at a maximum of 7 days (1 week) per approval, for a total of 21 days per plaza, per year.

Councilman Pearce questioned if an existing policy related to political signs should be included in the Code.

Director Ferris clarified that the Code regulates political signs for residential and non-residential properties, but not for Government Use (GU) properties, i.e. parks.

Mayor Flores opened the meeting to the public. He asked if anyone was in favor of, or opposed to, Ordinance 2018-03 to come forward. Seeing no one come forward, he closed the meeting to the public and called for a motion.

B. PUBLIC HEARING Ordinance No. 2018-06: Second Reading; Amending Chapter 6, Franchises, Article V, Solid Waste, Division 1, Section 6-276 Franchise Agreement, of the City of Greenacres Code to add a Fifth Addendum (Exhibit 6) to the Franchise Agreement; providing for repeal of conflicting ordinances; providing for severability; providing for inclusion in code; and providing for an effective date; pursuant to Staff Memo. – Teri Beiriger, Budget Analyst/Grants Coordinator.

City Clerk Joanna Cunningham read Ordinance 2018-06 into the record on second reading.

Budget Analyst/Grants Coordinator Teri Beiriger reported that Ordinance 2018-06 is the 5th addendum to the existing solid waste franchise agreement with Advanced Disposal. This addendum is a one-year extension to the franchise agreement for solid waste collection services through September 30, 2019. She reported there were no further changes to the Ordinance from first reading; therefore, staff recommends approval of Ordinance 2018-06.

Mayor Flores called on Council members for comments; hearing none, he opened the meeting to the public. He asked if anyone was in favor of, or opposed to, Ordinance 2018-06 to come forward. Seeing no one come forward, he closed the meeting to the public and called for a motion.

C. PUBLIC HEARING Ordinance No. 2018-11: Second Reading; Amending Chapter 8 entitled "Licenses and Business Regulations", Article III, entitled "Business Taxes", Section 8-72 entitled "Local Business Tax Schedule" as authorized by Section 205.0535(4), Florida Statutes; providing for repeal of conflicting ordinances; providing for severability; providing for inclusion in code; and providing for an effective date; pursuant to Staff Memo. – Michael Grimm, Building Director.

City Clerk Joanna Cunningham read Ordinance 2018-11 into the record on second reading.

Building Director Michael Grimm reported that business taxes are used for services and improvements that directly benefit businesses. State statutes allow local governments to increase rates every two (2) years up to a 5% maximum. He reported that Greenacres charges some of the lowest fees in Palm Beach County; therefore, staff recommends approval of Ordinance 2018-11.

Mayor Flores called on Council members for comments.

Councilman Pearce noted that the state legislature has had many discussions on this topic to abolish the municipal contractor fees. He asked if the City has access to County contractor licensing/insurance records.

Director Grimm confirmed that the City uses the County's online registration program to check licensing and insurance information.

Mayor Flores called on Council members for comments; hearing none, he opened the meeting to the public. He asked if anyone was in favor of, or opposed to, Ordinance 2018-11 to come forward. Seeing no one come forward, he closed the meeting to the public and called for a motion.

Deputy Mayor Bousquet made a motion to approve Ordinance 2018-11 on second reading. Councilman Tharp seconded the motion.

D. Resolution No. 2018-21: Approving an Agreement between the City of Greenacres and the Palm Beach County Office of Information Systems Services for the assignment of property data and development of annual assessments related its non-ad valorem assessment roll, authorizing the appropriate city officials

to execute the agreement, and providing for an effective date; pursuant to Staff Memo. – Teri Beiriger, Budget Analyst/Grants Coordinator.

Joanna Cunningham, City Clerk, read Resolution 2018-21 into the record.

Budget Analyst/Grant Coordinator Beiriger reported that Resolution 2018-21 is an agreement between the City and PBC Information System Services (ISS) to convert the City's non-ad valorem tax assessments into a compatible medium to facilitate readability by the Palm Beach County Tax Collector's and Palm Beach County Property Appraiser's Offices, at a cost of \$2,600/year. Staff recommends approval of Resolution 2018-21.

Mayor Flores called on Council members for comments; hearing none, he called for a motion.
