State Mandates Property Tax Cuts

On June 21, 2007, the Governor signed three (3) Bills passed by the legislature during the special session that ended on June 14, 2007.

- HB 1B: This Bill limits the authority of local governments to levy ad valorem taxes for the budget years 2007/2008 and beyond. For the 2007/2008 budget year, ad valorem taxes will be capped at the roll back rate (millage rate that produces the same amount of revenue as last year 2006/2007) less 9% for the City of Greenacres. This amount reduced revenues received from taxes by \$985,082. In order to address the cuts in revenue in the 2007/2008 budget and plan for future budget years in light of the constitutional amendment on January 29, 2008, the following measures were proposed for the budget:
- 1. Reduce the shortfall in revenue over expenditures for non-essential services including special events, athletic leagues, and classes. This includes eliminating three (3) special events (Greenacres Fest, Holiday in the Park, and Love on the Lawn), increasing fees for participation in athletic leagues to offset costs, and restructuring Leisure classes to be offered through renting space to instructors.
- 2. Maintain six (6) current positions vacant. These vacancies will impact the levels of service delivery by lengthening the amount of time it takes to perform some services.
- 3. Eliminate 500 part-time and 700 independent contractor hours.
- 4. Reduce training costs by 20%.
- 5. Reduce operating line item budgets across all Departments by \$213,000.
- 6. Reduce inter-fund transfers in the FY2008 and future years.

For the 2008/2009 budget and beyond, ad valorem taxes will be capped at the rolled back rate plus an adjustment based on the growth of the per capita personal income.




FY 2008 BUDGET

On September 17, 2007, the City Council approved a budget for Fiscal Year 2008 which covers the period from October 1, 2007 to September 30, 2008. The General Fund, which accounts for the majority of City services and operations, had an appropriation of \$23,772,466 for FY 2008. Property taxes represent approximately 40% of the General Fund revenue, while the remaining 60% is comprised of franchise fees, state sales tax, charges for services, permits and licenses, interest income, and miscellaneous charges.

The property tax revenue is based on the taxable value of all property within the City multiplied by the property tax rate. As of July 1, 2007, the total of taxable property in the City was \$2,152,750,751. The property tax rate adopted by the City Council was 4.7022 mills or \$4.7022 per \$1,000 of taxable property value. This rate represents a decrease of 9% over the prior year's rate and is estimated to generate approximately \$9,626,422 in revenue.

For a home with a property value of \$225,000, with a \$25,000 Homestead Exemption, the annual property taxes paid to the City of Greenacres would be \$940.44 which represents a savings of \$169.56 from the previous year. The City has continued to demonstrate fiscal responsibility by lowering the property tax rates over the years as shown on the following chart.



PUBLIC SAFETY TIP ON IDENTITY THEFT

Identity Theft involves the use of personal identifiers such as names, social security account numbers, and credit card numbers, typically for criminal purposes. To minimize your risk of becoming a victim of identity theft you can:

- Place outgoing mail in secure collection mailboxes
- Only carry essential identification cards
- Before providing any personal identifiers, know how it will be used and if it will be shared
- Know your billing cycles and contact creditors when bills fail to show up
- Do not give personal information over the telephone
- Shred documents that contain personal identifiers or account information.

Protect yourself by registering to limit the number of telemarketing calls you receive and checking your own credit report.

Even though you may take precautions to ensure that your personal identity and information is safe, you could still be the victim of identity theft. Below are some steps to take if you do become a victim.

 Report the case to your local law enforcement agency and obtain a case number. The report can be filed in the city or county in which you reside, or the location where the offense occurred. When available, obtain a copy of the report.

- Notify the three major credit bureaus. Order copies of your credit report. You can also have a fraud alert placed on your credit report. Request that creditors contact you prior to opening new accounts or making changes to any of your accounts
- Contact the fraud department of each of your creditors. You may be requested to complete an affidavit disputing the fraud. Confirm all conversations in writing and keep copies of all documentation.
- Contact your banking institution. If you believe that your account has been compromised, close your checking and savings accounts and obtain new account numbers. Stop payment on any stolen checks.
- Contact the Department of Highway Safety and Motor Vehicles (DHSMV) and have a flag placed on your driver's license. If your personal information was actually used to secure a driver's license, DHSMV will conduct an investigation.

PUBLIC SAFETY REACHES OUT TO THE COMMUNITY WITH VARIOUS PROGRAMS

The Fire/EMS Services Division takes pride in teaching the community new techniques in Cardio Pulmonary Resuscitation (CPR), providing blood pressure screenings, and presenting public awareness lectures. The Fire/EMS Services Division participates with the Palm Beach County Health Department, providing Influenza, Pneumococcal, and Tetanus Vaccines to seniors, 60 years of age and older, and their caregivers. Additionally, the Division conducts fire inspections and investigations throughout the city. SOLID WASTE SERVICES

The City of Greenacres contracts with Onyx Waste Services Southeast (Onyx) to provide solid waste services. There are up to four (4) categories of pickup services depending on your collection type-curbside or dumpster.

RESIDENTIAL CURBSIDE COLLECTION:

- Collection of regular household garbage/trash twice a week.
- Collection of bulk trash, recycling, and yard vegetation once a week.
- Trash will be collected from 7 a.m. 6 p.m.,
 Monday through Saturday (except the Thanksgiving and Christmas Holidays).

RESIDENTIAL DUMPSTER COLLECTION:

- Collection of regular household garbage/trash twice a week.
- Collection of bulk trash and recycling once a week.
- Trash will be collected from 7 a.m. 6 p.m., Monday through Saturday (except the Thanksgiving and Christmas Holidays).

Please make sure to place your waste outside prior to 7 a.m. for prompt collection.

Residential customers are encouraged to call the City of Greenacres, Public Works Department at (561) 642-2071 with any questions, complaints, issues, requests, or concerns related to the pick-up and disposal of solid waste.

HOUSEHOLD HAZARDOUS WASTE

The Solid Waste Authority (SWA) provides free disposal of common household chemicals for residents of Palm Beach County. Almost every home has some type of chemical product that can be hazardous if not used, stored, or disposed of properly. Pesticides, cleaning products, solvents, pool chemicals, paint, used oil, and propane cylinders are just a few examples. When they are no longer needed or usable we refer to them as "Household Hazardous Waste", or HHW for short. 
A SUCCESSFUL GREAT GREENACRES CLEANUP


