#### PALM BEACH COUNTY CHARTER AMENDMENT

On November 4, 2008, in conjunction with the General Election, Palm Beach County voters will be asked to vote Yes or No on an amendment to the County Charter that would require both County and Municipal approval of charter amendments affecting municipal power or function.

#### What is the charter amendment?

The amendment provides that when future County-wide amendments transfer or limit municipal service, function or power, they will take effect in a municipality only when approved by a majority of County voters and city voters. The amendment will protect city residents from changes to services and regulatory authority against their wishes.

#### What does this Amendment do?

This Amendment allows city voters to protect the unique character of their city. Voters countywide would no longer be able to change service or regulatory authority within a city without the approval of city voters. It essentially allows city voters to opt out of County regulations that don't fit their city.

#### Don't the Cities already have this right?

Almost. The Constitution protects municipal power and function. This Amendment extends that protection to municipal service and regulatory authority. Cities in Palm Beach County have the right to make rules that don't conflict with county, state or federal law, except in four areas already written into the County Charter. Those are traffic performance standards, well field protections, countywide impact fees and annexations in western Palm Beach County.

#### How would this affect individual cities?

The "character" of a community is determined by local standards. The voters in each city should be allowed to set unique community standards. Some examples of community standards include: building appearance rules, building height requirements or limits, building set-backs, city density, city green space, historical preservation, public safety standards, sign ordinances, and zoning.

#### What will this cost?

Absolutely nothing.

#### Would unincorporated residents be affected by this?

No. Regulations in unincorporated parts of Palm Beach County would still be determined by countywide vote.

#### What is the City of Greenacres' Position on this issue?

The City Council has passed a resolution in support of this change to the County Charter and asks residents to vote on this issue on the November 2008 Ballot.

#### FY 2009 PROPOSED CITY BUDGET

The City Council will hold public hearings on September 3rd and 15th at 7:00 p.m. at the City Hall Council Chambers to adopt a budget for fiscal year 2009 (October 1, 2008 – September 30, 2009). The City's proposed general operating budget for FY 2009 is \$23.5 million and is based on maintaining the previous year's Millage rate of 4.7022. Millage is the tax rate levied by a city on taxable property per each \$1,000 of assessed taxable value. The proposed tax rate represents a 12.20% reduction in the amount of property tax revenue collected or approximately \$1.2 million less than last year's revenue. To make up for the deficit, the City is using several approaches that include continuing implementation of various cost cutting measures, eliminating vacant positions, and using reserves. Between 2000 and 2008, the City reduced the total property tax rate by approximately 23%, and in 2009 the property tax rate represents more than a 14% drop below the rollback rate, which is the Millage rate that would produce the same amount of tax revenue as the previous year.





#### STORMWATER SYSTEM MAINTENANCE

Heavy rainfall and flat terrain in South Florida causes flooding problems, and the cost for correcting the damage is always high. Prevention of stormwater problems through proper maintenance is far easier and less expensive than correcting them. The path of storm-water begins in the neighborhoods and commercial plazas and travels to city, county or local drainage district canals and finally to South Florida Water Management District canals or natural rivers.

In the City of Greenacres, homeowner's associations and commercial plaza owners are responsible for the operation and maintenance of their own stormwater management system. Failure to provide proper maintenance reduces the overall flow capacity and pollutant removal efficiency. Keep your stormwater system as efficient as possible by doing the following:

- Conduct routine inspections on outfall structures and catch basins to ensure no obstructions are present.
- Keep all inlets, pipes and culverts clean and free of debris. The grates should be kept unobstructed and any sediment, trash or debris in the inlets or pipes should be removed.
- Mow swales and grassed areas regularly, and keep those areas free from yard waste, clippings or vegetation.
- Remove dead vegetation, trash and debris from lakes, ponds, and canals.

#### CITY COUNCIL ACTIONS



The following are highlights of actions taken by the City Council at their meetings:

- Approved site plan modifications for Greenacres Plaza that included the construction of a Starbucks building and major renovations to the entire plaza which is located on the northwest corner of Jog Road and Lake Worth Road.
- Awarded six (6) Scholarships of \$1,500 each to high school and college students to assist them to further their educational endeavors.
- Approved a site plan modification to the Burger King site for the construction of a new building, as well as new landscaping at the intersection of Jog Road and Lake Worth Road.
- Held a workshop for Fiscal Year 2009 Budget and set the Public Hearings for Wednesday, September 3 and Monday, September 15, 2008 at 7:00 p.m. at the Greenacres City Hall, 5800 Melaleuca Lane.
- Approved an Ordinance prohibiting sexual offenders and predators from residing within 1500' of schools, public libraries, day care centers, parks, playgrounds, community centers, day camps or other places where children regularly congregate.
- Approved a Special Exception for a house of worship at 6024 Lake Worth Road.
- Received "100 Best Communities for Young People" Award by America's Promise – The Alliance for Youth in Washington, D.C.
- Received an award for Certificate of Achievement for Excellence in Financial Reporting and an award for Financial Reporting Achievements.
- Inducted re-elected City Council members:

   Doris A. Fouts, Councilwoman District IV
- Awarded 4 adult and 47 youth Presidential Volunteer Service Awards.
- Approved a Resolution to increase measures to become a "Green Local Government" through improved environmental performance, using criteria and standards developed by the Florida Green Building Coalition, and encouraging the Legislature and Governor to support the Green Local Government Program.
- Amended Chapter 14, Traffic and Vehicles, regulating the parking of motor vehicles, trucks, commercial vehicles and recreational vehicles on road rights-of-way.
- Authorized submittal of written objections to Palm Beach County relative to the density of the "Colony of Lake Worth Development".

- Authorized the submittal of a Program Application and Budget for FY 2009, between the Children's Services Council of Palm Beach County and the City for the "Greenacres Youth Programs," an afterschool program for elementary and middle school youth, from October 1, 2008 to September 30, 2009.

- Approved the Interlocal Access Agreement between Palm Beach County and the City of Greenacres to access Palm Beach County's 800 MHz Trunked Radio System for Public Safety Communication.
- Received recognition by Solid Waste Authority for the City's Outstanding Recycling Participation.
- Amended lien search fees for title searches which are conducted upon real property located within the City.
- Approved a contract between the Florida Department of Corrections and the City for the purpose of providing a work squad(s) to assist in maintaining City right-of-ways and grounds for Fiscal Year 2009.

#### GREENACRES HISTORICAL SOCIETY INC.

The Greenacres Historical Society, Inc. (GHS) received approval from the State of Florida for incorporation on December 27, 2006. Since that date, the GHS has been working diligently collecting historical artifacts, setting up their museum at 525 Swain Blvd., hosting presentations from well-known historians, increasing their membership, and applying for grants to support the museum.

Some of the most recent activities and accomplishments include:

- Dedication of the museum at 525 Swain Blvd. which is open on Tuesdays and Thursdays from 2:00-5:00p.m.
- Receipt of the first corporate grant in the amount of \$1,000 from the Wal-Mart Foundation.
- Planning a garage sale fund raiser on August 2nd at the American Legion building at 364 Swain Blvd.

The Society continues to seek artifacts, photos or donations to enhance the museum. Items may be dropped off during the museum hours. ### PROPER DISPOSAL OF RESIDENTIAL HAZARDOUS WASTE

Used oil, paint and pesticides are just a few examples of the hazardous material that most residents have in their homes or garages. To ensure that these items are properly disposed of, so that the environment is not impacted, residents can take their household hazardous items to one of the Solid Waste Authority's Household Hazardous Waste Collection Centers. The closest centers to city residents are located at 1810 Lantana Road and 9743 Fairgrounds road.

Old electronic equipment such as televisions, VCR's, stereos, computer monitors and computer CPU's can also be taken to the collection centers where they will be sorted and hauled away by a certified electronics recycler. ### 2-1-1 INFORMATION, REFERRAL & CRISIS SERVICES

The Center for Information & Crisis Services is a private non-profit health and human services agency that has been in operation since 1971 and it serves all of Palm Beach County. This Center serves as the central access point for information, referral, telephone counseling, crisis intervention, and suicide prevention, via telephone 24 hours per day, 365 days per year. The CrisisLine, Elder HelpLine and Teen HotLine are available by dialing 2-1-1. Information can also be accessed through their website http://www.211palmbeach.org. The information provided is free and the referral and crisis services are confidential and non-judgemental.

Some of the situations that the center deals with daily include:

- Referrals for assistance for health and human services in times of crisis:
- Single parents trying to make it on their own; or struggling with out-of-control kids
- The cycle of chemical and alcohol dependency among family members;
- Adult children concerned about their aging parents;
- The elderly trying to retain their independence and needing medical and human services;
- The cycle of spousal and child physical and verbal abuse:
- Depressed individuals trying to keep their lives together;
- Children and teenagers upset and wanting to talk to someone;
- Teenagers struggling with adolescence, school and home;
- Financially disadvantaged people of all ages who are on the verge of being evicted, or losing their electricity and water;
- Teachers, social workers, nurses and other professionals working to meet the complex needs of their clients.

#### RECYCLING AT CITY PARKS

With the increased use of park facilities, the City has taken steps to increase the reduction of waste to help the environment. Twenty five trash receptacles at various park pavilions and gazebos have been converted for

use as recycling containers. Each container is identified with the universal recycling logo and a sticker indicating Glass, Aluminum, and Plastic only.

Recycling in parks is just like recycling at home; recyclables consist of aluminum cans, glass, and plastic drink bottles. According to the Environmental Protection Agency's Office of Solid Waste, if every American recycled just one plastic beverage bottle while on the go, this would divert more than 8,000 tons of recyclable material from the waste stream!



#### IMPROVEMENTS AT FREEDOM PARK

Several improvements have just been completed at

the City's newest park located at 2400 Pinehurst Drive (just south of Okeeheelee middle school). A new restroom building was recently opened at the south end near the



soccer fields and two covered picnic shelters were installed on the west side of the lake. The shelters expand recreational opportunities at the park with each shelter seating 4 to 6 adults. These are in addition to the two existing pavilions with picnic tables.

The 52 acre park is open from sunrise to 10:00 p.m., and has lighted soccer and ball fields, walking path, playground equipment, two pavilions with picnic tables and two restroom buildings at each end of the park.


#### FOOTBRIDGE CLOSED

The City closed the pedestrian footbridge between the Original Section and the Lake Worth Hills Community over the E-3 Canal. The footbridge, which was constructed in the early 1970's, was deemed unsafe for pedestrian usage following an inspection by an engineering consulting firm. The footbridge has been scheduled for demolition at the end of this year.




