Items are ordered on an "as needed" basis through the City's fiscal year (October 1 through September 30).

15. Regarding the Nitrile Gloves on lines 118-122, we are unable to locate the same gloves (nitrile) from any previous orders. Do you have a previous bid tabulation that reflects the nitrile gloves? The previous bid tabulation 24-004 only reflects latex gloves.

The Fire Rescue Department decided to switch from Latex Gloves to Nitrile Gloves.

16. Also regarding the Nitrile Gloves (lines 118-122), how often are orders placed? In addition, how many cases of gloves are generally ordered at one time?

The Bid Proposal Form indicates the order quantity for the year. Items are ordered on an "as needed" basis. However, gloves are typically ordered every two weeks. A typical order usually consists of 5 cases of one size and 2 of another. However, timing and quantity are dependent on call volume
